

## MID-OHIO DRESSAGE ASSOCIATION 2020 COMPETITION RECOGNITION FORM

Every year MODA includes the very best shows in Central Ohio, and welcomes scores earned there by MODA members, to count toward Year-End Awards Program. Please help us create the best experience possible for your competitors by following these guidelines:

- 1) This application should be received 45 days prior to date of show to ensure communicating to central Ohio dressage community through the MODA newsletter and website.
- 2) The show must follow USEF/USDF guidelines.
- 3) The venue must provide safe competition arenas as near to USEF requirements for a Level 1 dressage competition (see USEF rule DR126). It is understood some indoor arenas may not meet the requirements, but every effort should be made to be consistent.
- 4) MODA strongly recommends carrying insurance for your show.
- 5) Judges must be USDF L Graduates, USEF Dressage judges, or retired dressage judge. **With prior approval**, a person the MODA Board has deemed qualified is acceptable for Walk/Trot classes or non-dressage test classes such as equitation or jumping.
- 6) Included with the submission of this form, applicants must pay to MODA a fee of \$10 per show for which they are seeking MODA recognition.
- 7) **Results must be sent to the MODA Awards Chair.** A link to a MS Word, Excel, or PDF file is acceptable and can be emailed to Christine Talbert at [ctalbert518@gmail.com](mailto:ctalbert518@gmail.com).
- 8) All prize lists and show bills must designate the show being "Recognized by Mid-Ohio Dressage Association."
- 9) MODA tries to adhere to USDF Awards season that runs November 1 to mid-October for the purposes of the MODA Year End Awards Program.
- 10) NOTE: Although scores earned at your shows count towards MODA Year End Awards, volunteer hours for your shows do NOT. Please see volunteer opportunities at [midohiodressage.com](http://midohiodressage.com)
